- ii. Principal Jennifer Cassidy Still working on Strategic Plan goals and how that fits into mission and philosophy. Weekly staff meetings. K-5 new math program fits with IB, Middle School consistency with kids and keep it vibrant. Goal setting with teachers, letting people know that it does matter so talk to Jennifer Cassidy if you have concerns. MAP testing 3<sup>rd</sup> year so we can start to analyze trends/data.
