 - Strategic Planning Committee presented questions being asked and goals of information learned through survey. Review emphasized the continuity of the format, but contemplated removing/changing questions to better gauge community sentiment.
 - Survey will go out roughly March 1st, run through spring break. Data will be presented at ASC's May 2024 meeting.

V. General Reports 7:25 pm

- <u>Principal's report</u> Update on Dancing with the Annunciation Stars (~\$96,000 raised), CSCOE's event in Florida; Centennial Fund has so far raised \$355,000 (\$145,000 from triggering additional \$500k pledge); and a look at the remarkable achievement and improvement in oral reading fluency of our 1st-3rd grade students since Fall 2023.
 - o 16% high risk down to 5% high risk.
 - 15% moderate risk to 19% moderate risk.
 - o 46% at grade level up to 49% at grade level.
 - 22% above grade level up to 27% above grade level.
- <u>Church updates</u> Fr. Deziel reminder that Lent begins Feb. 14th. Coffee House and Fish Fry in the coming weeks.
- APO updates No update.
- Enrollment and Health Office updates influenza and strep are prevalent in school; civid restrictions are loosening per CDC. Currently at 30 in kindergarten for the fall. Marketing events will continue, including Open House, Curiosity Fair and Fish Fry, and Jolly Pops band in conjunction with LADC in April.
